
Update on non-Annex I National Communications

CGE was reconstituted at COP15 (December 2009) for a period of three years from 2010 to 2012.

<Objective>

To improve the process of and preparation of national communications from NAI Parties, by providing technical advice and support to non-Annex I Parties.

To this end, CGE members are working to:

- Identify and assess technical problems and constraints affecting Parties in preparation of national communications
- Identify and assess the difficulties encountered by Parties in the use of guidelines and methodologies
- Examine specific sections of national communication in terms of methodological issues, technical problems and constrains in preparing and reporting
- Provide technical advice and support through training workshops
- Provide recommendations on how to improve the preparation of different chapters of national communications





For example, CGE analyzed problems through questionnaire, and...

CGE recommends assistance be provided to NAI Parties:

- Continuity of inventory preparation (e.g., maintaining inventory team)
- Improvement of data collection processes (e.g., communicating with other national data providers)
- Implementation of key category analysis to prioritize inventory-related activities
- Development of country-specific emission factors if necessary, and where emissions are significant (following key category analysis)
- Implementation of completeness checks and accuracy improvement in key categories
- Use of IPCC Emission Factor Database
- Conducting training activities to develop national expertise





CGE considers the following important in facilitating the improvement of NC preparation:

- Continued support by the secretariat for NAI Parties to use the UNFCCC GHG inventory software
- Nomination by NAI Parties of their experts to the UNFCCC roster of experts in order to participate in the review of the AI GHG inventories
- Regional training workshops (Subject to availability of funds...)
 - Thematic workshops GHG inventory, Adaptation, Mitigation
 - On GHG inventory:
 - Hands-on training
 - Cross-cutting issues (continuity, key category analysis, QA/QC, etc.)
 - Sectoral issues (activity data collection, development of emission factors, etc.)

WGIA is a good example!!!
